### **IOP Task Force on Equity in Dual Enrollment and Preapprenticeship Programming**

### **Project Goal:**

To develop specific, targeted policy recommendations that are actionable at the state level that will support increased access to and equitable participation in dual enrollment and pre-apprenticeship programs.

### **Rationale:**

To advance college and career readiness in Pennsylvania, more students need to be able to pursue postsecondary education and training. Dual enrollment and preapprenticeship programs are proven practices that have demonstrated impacts in helping students transition successfully from K-12 education and persist once enrolled in college/career training.

#### IOP Task Force on Equity in Dual Enrollment and Preapprenticeship Programming

- Findings
  - Need for additional data to:
    - Determine which students have access to programming
    - Evaluate program effectiveness and determine funding needs
  - Need for greater cooperation between entities
    - PDE, DLI, and other state agencies
    - Traditional high schools and CTCs
    - Community colleges and universities

11 recommendations in the areas of:

- goal setting around equity and access
- making programs more navigable for students and families
- increasing the transferability of credits earned
- ensuring program quality
- supporting additional data collection

- PDE guidance on \$7 million budget allocation
- PCHE credit transferability project
