I have attached a bullet-pointed list of all of my questions below. If it would be better to chat, let me know and we can get something scheduled.

- Where can I find a template for the protocol attachment section?
- The All of Us program gives us \$300 for the workbench. Would that count as external funding?
- We are obtaining data from the All of Us research program and are not actively recruiting or consenting people. How should I answer the consent process or study scope questions?
 - What should I do for the consent form?
- The same for the security questions. Should I write down the security that All of Us has in place to protect data and patient information?
 - The program asks participants to fill out surveys and they have an option to wear a device, such as Fitbit. Do I need to select those options and then fill out the information (if I can find it)?
- For research activities, should I explain what tests/analysis I plan to run on the data?
 - The All of Us program does have surveys that participants can fill out, but I am not sure if I need to include those forms in the IRB.
 - Also, the All of Us program also collects blood but since I was not a part of that process, do I still need to select yes and fill out that information?
- Data Safety and Monitoring section: since we are not actively monitoring/recruiting participants, do I need to have a monitoring plan in place?
- Again, we are looking at the available data from All of Us, what should I put down for the risks and benefits section since it does not pertain to individuals?
